Loanee farmers will have their insurance processed by their loan-granting institutions (Banks and NBFCs), while non-loanee farmers can insure their crops at the nearest bank branch, Common Service Centre (CSC), post office, authorized intermediaries through the AIDE app, or via the NCIP Portal (farmer self-login at pmfby.gov.in). Under this scheme, farmers only need to pay a maximum of 2% of the insured sum as a premium, making crop insurance more accessible and affordable for them.
